### NOTICE

#### **Sub : Prohibition of Ragging at IICD**

#### **Attention: All Students of UG/ PG Programmes**

This is for the information that the Anti Ragging committee has been formed to control the menace of Ragging and to protect the interest of the freshers, to prevent all sorts of Ragging inside the IICD premises including hostels.

If anyone is found to be involved in ragging or this act is reported to the anti-ragging committee then the committee will take action against the concerned student/ students involved as per the following:

- A. As per the Directives of Hon'ble Supreme Court in its ruling on the subject, Ragging constitutes one or more of any of the following acts:
1. Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
  2. Indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
  3. Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.
  4. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
  5. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
  6. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
  7. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person.
  8. Any act or abuse by spoken words, emails, posts, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.



9. Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.


B. Ragging will be treated as a major disciplinary violation and the offenders (direct or indirect) will be treated as per guidelines laid by The Supreme Court in its ruling on the subject. Any Complaints on this issue are to be made to the Anti Ragging Committee of ICD for action. It may be necessary for the Institute to bring the case of ragging to the notice of concerned authority/police.

C. Depending upon the nature and gravity of the offense as established the possible punishments for those found guilty of ragging at the Institution level shall be any one or any combination of the following:

1. Suspension from attending classes.
2. Withholding/withdrawing scholarship/fellowship and other benefits.
3. Debarring from appearing in any test/examination or other evaluation process and/or withholding results.
4. Fine with public apology.
5. Suspension/expulsion from the hostel.
6. Rustication from the institution for a period ranging from 1 to 4 semesters.
7. Expulsion from the institution and consequent debarring from admission to any other institution.
8. Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.


If any Fresher feels that he/she was ragged, then he/she may submit a written allegation against the raggers within 24 hours or may report on email [dracademics@iicd.ac.in](mailto:dracademics@iicd.ac.in), mobile number **9460673297** to the following persons for necessary action :-
